Sustainably embed Medications for Opioid Use Disorder (MOUD) education into residency and advanced practice provider curricula as well as increase system and workforce capacity to treat Opioid Use Disorder (OUD) across all 100 counties in North Carolina.





\*Please note: Participation by course type and by provider type have decreased across time due to scope of work and funding limitations as well as successful integration and sustainability of MOUD education into curricula.




